(Revenue \$) SINCE 1976, JEANNETTE RANKIN WOMEN'S SCHOLARSHIP FUND HAS PROVIDED CRITICAL SUPPORT TO LOW INCOME WOMEN OVER THE AGE OF 35 FOR POST SECONDARY EDUCATION. WE HAVE GIVEN OVER 1,100 SCHOLARSHIPS TO 825 WOMEN IN THE AMOUNT OF \$2.3M. OUR SCHOLARS REPORT A 95% COMPLETION RATE COMPARED TO THE NATIONAL AVERAGE OF 38% FOR WOMEN OVER THE AGE OF 35. JEANNETTE RANKIN SCHOLARS ARE ABLE TO LEVERAGE THE SCHOLARSHIP, USING IT TO FILL IN THE GAPS FOR EXPENSES NOT COVERED BY OTHER SCHOLARSHIPS INCLUDING: BOOKS, CHILD CARE, HOUSING EXPENSE, AND CAR REPAIRS. THERE ARE MULTIPLE STORIES ABOUT HOW A FLAT TIRE CREATED A DOWNWARD SPIRAL THAT ENDED A COLLEGE EDUCATION. OUR GOAL IS TO MAKE SURE THAT DOES NOT HAPPEN TO OUR SCHOLARS. WE ALSO PROVIDE COACHING AND SUPPORT, HELPING THIS NON TRADITIONAL STUDENT NAVIGATE THE OFTEN
